IMO Data Collection System(DCS) requirement in accordance with MARPOL Annex VI Chapter 4.

The Mercantile Marine office hereby reminds all concerned that IMO adopted mandatory requirements related to Data Collection System for fuel consumption of ships (IMO DCS) as amendments to Chapter 4 of Annex VI of MARPOL convention (Resolution MEPC 278(70)) which entered into force on 1st March 2018 applicable to all ships of 5,000 gross tonnage and above

Ship owners & Ship managers of Bangladesh flag vessels of 5,000 gross tonnage and above are required to comply followings

- 1) Prepare SEEMP II (IMO DCS) as per guidelines of IMO Resolution MEPC 282(70), submit to Bangladesh flag delegated RO's and obtain RO's approval prior 31st December 2018.
- 2) Data collection to be started from 1st January 2019 for consumption of every fuel oil type they use, as well as other data like distance travelled, time spent at sea and deadweight to calculate the transport work;
- 3) Collected Data shall be aggregated for the period 1st Jan 2019 31st Dec 2019;
- 4) Data shall be reported to this department & ROs latest by 31st March 2020;
- 5) Statement of Compliance (SoC) issued by the ROs after validation of data shall be placed and kept available on board.
