Joint Concentrated Inspection Campaign (CIC) of MARPOL Annex VI by Paris MOU, Tokyo MOU & Indian Ocean MOU.

The Mercantile Marine office hereby reminds all ship owners, ship managers, Recognized Organization & others concerned that as per press releases published on Paris, Tokyo and Indian MOU web pages; a joint Concentrated Inspection Campaign (CIC) is being carried out by Paris, Tokyo and Indian MOUs from 01 September 2018 to 30 November 2018.

To avoid detentions of Bangladesh flag vessels during the joint Concentrated Inspection Campaign (CIC) by Paris, Tokyo and Indian MOUs requires all addressed parties to ensure that ship's procedure and measures are in place with respect to MARPOL Annex VI.

Furthermore, the Port State Control Officers will use the attached questionnaire during the CIC, which contains 11 selected questions to establish the level of compliance with the requirements of MARPOL Annex VI within the shipping industry; creating awareness amongst ships' crew and ship owners with regard to the importance of compliance with the provisions of MARPOL Annex VI and the prevention of air pollution.

With the aim of avoiding any PSC issues and as well as to ensure that the ISM Operators fleet are ready for this CIC, the ISM Operators to contact their Master (s) to complete the attached questionnaire for each of their ship (s).
